Believe updating software on electronic devices does not do anything to increase the productivity of the machine? Think again. Examples include bug fixes, providing critical upgrades to the device, preventing the device from crashing, and much more.

While the classic Southern phrase, "If it isn't broke, don't fix it" applies in several other areas, it creates a common misconception among technology users that devices do not need to be updated or changed just because they are still working. Computers begin to lag if they are not updated properly, which may cause them not to operate well. Remaining loyal to obsolete technology when more useful programs have been created may result in lost productivity for employees and business owners.

Electronic gadgets such as smartphones and laptops are often released with more powerful specifications than programs at the device's release can utilize. This means that when these devices are released, the software is often created for older products. Programs need to be developed to benefit from the newer, more powerful machines.

Once software is created to utilize the full capability of a machine, it becomes necessary to update programs periodically to ensure continued compatibility with the device. Applications can become slow and frequently freeze, hindering the performance of both the program and the machine itself. Users are required to update software on a device to fix bugs, "A problem that causes a program to produce invalid output or to crash (lock up)."
